It is regulated by IPMAs CVMB through IPMA validation in accordance with the IPMA International Certification Regulations (ICR).

<b>Payment Terms</b>	Certification fees must be paid in full for on application.

<b>Membership</b>	Applicants are not required to become a member of IPMA-Australia MA to apply for certification. Applicants must however join as a member prior to applying for certification to receive IPMA-Australia certification discounts.
<b>Duration</b>	For a Candidate to be awarded an IPMA Certificate, you must have successfully completed each of the assessment steps for the level applied for within eighteen (18) months from the date of application acceptance or the application is cancelled and a new application required.
<b>Cancellation</b>	<u>Cancellation</u> is defined as a candidate no longer wishing to continue with the certification process as defined in the IPMA-Australia CB Certification process, failing to attend a pre-agreed assessment (date/time), or failing to complete the assessment steps in time.
<b>Review</b>	Fees subject to regular review by IPMA-Australia but once an applicant has submitted their application, fees will be fixed as long as certification is finalised within 12 months.
